Clarenceville School Annual Education Report

February 14, 2025

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2023-24 educational progress for Clarenceville High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2024-25 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2023-24. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state, had a graduation rate at or below 67%, or failed to exit ATS status in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school does not have any labels. No subgroups fell below the threshold to be identified with any labels.

The key challenges persisting this year continues to revolve around closing achievement gaps through bolstering our core instruction to cater to diverse student needs. We remain committed to monitoring achievement data closely to tailor support for every student, fostering a conducive learning environment. Furthermore, transportation and family logistics constraints continue to pose significant obstacles to daily attendance for our students and families.

State law requires that we also report additional information.

1. Students are assigned to Clarenceville High School on a roll-up basis from the lone middle school in the district. Schools of Choice students are selected through the state defined process and as approved by the Clarenceville School District Board of Education.
2. Our School Improvement Team is actively engaged in a comprehensive process aimed at enhancing student learning outcomes. Our School Improvement Plan is meticulously crafted to comply with both federal and state directives.

Clarenceville High School, within the Clarenceville School District, holds accreditation from AdvancEd and is dedicated to sustaining and improving our Michigan Integrated Continuous Improvement (MICIP) framework. Our entire school community is united in pursuit of our [Michigan Integrated Continuous Improvement \(MICIP\)](#) goal, which focuses on academic objectives, necessary strategies, and interventions to continually advance student growth. This endeavor encompasses both building and district Multi-Tiered Systems of Support (MTSS).

As part of a district-wide initiative, we have shifted our focus back to the Principles of Effective Instruction, which have been revamped by the district administrative team. These principles guide our instructional practices and ensure alignment with research-based strategies that foster student engagement and achievement. Our plan outlines specific goals and initiatives in English Language Arts (ELA), mathematics, social-emotional learning (SEL), and career readiness. These efforts are closely aligned with our district's strategic plan and the State of Michigan Career Readiness initiative, ensuring a cohesive and targeted approach to student success.

3. Clarenceville High School is a comprehensive high school with 554 9-12 students. Approximately 39.1% are White, 51.8% are African American, 5.4% are Hispanic, 3% Asian American, and 0.3% identify with multi-racial as their reporting ethnicity. 4.8% of our students are English Learners. About 55.8% of the students at Clarenceville High School are considered economically disadvantaged. As of the writing of this document, 10.5% of Clarenceville High School students are students with active, special education individualized education plans.

6. 411 (65% of our student population) Clarenceville High School students were represented at parent-teacher conferences in the 2023-24 school year.

 - a. Eleven students were enrolled in dual enrollment or post-secondary program courses.
 - b. Eighteen students were enrolled in the Accelerated College Experience (ACE) program through Oakland Schools.
 - c. Four students were enrolled in the Oakland Technical Early College (OTEC) program through Oakland Schools
 - d. There were 6 Advanced Placement courses.
 - e. During the 2023-24 school year, 94 students took Advanced Placement courses.
 - f. 103 students took Advanced Placement exams and passed 42 exams with a 3 or higher.

Clarenceville High School continues its commitment to providing rigorous and supportive learning pathways for our students. Our mission remains steadfast in challenging students to thrive as lifelong learners in an increasingly diverse, technology-driven, and dynamic world. We take pride in offering a wide array of experiences to ensure our students are well-prepared for the challenges and opportunities ahead.
